## Payment of School Fees

1. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees on time.

2. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 30 days.

3. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 60 days.

4. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 90 days.

5. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 120 days.

6. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 150 days.

7. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 180 days.

8. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 210 days.

9. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 240 days.

10. The school reserves the right to suspend or terminate the enrolment of any student if the student fails to pay the school fees for a period of 270 days.
